Terms of Reference(ToR)

1. Introduction:

"State Institute for Development of Arts & Crafts" (SIDAC) is an organization under Handloom, Textiles & Handicrafts Department, Government of Odisha, registered under societies registration Act XXI of 1860 bearing no 21959/137 of 2004-05 dated 15.10.2004 with its registered office at Handicrafts Complex, Gandamunda , Bhubaneswar. It has been created to function as an autonomous agency for all round development of Handicraft sector of the state such as :Survey and diagnostic study of crafts and craft clusters, Capacity building of artisans/Entrepreneurs, Cluster development programme, Facilitation for Export marketing, Participation in International Level Trade Fairs, Organization of National Level Exhibitions, Enterprise Development, Revival of languishing craft, Craft Documentation, Establishing Common facility centre, GI and IPR registration of crafts & Artisan Welfare.

The organization has been recognized as a "Centre of Excellence" in the field of non-formal technical training by the ministry of Skill Development and Entrepreneurship, Govt. of India.

2. Objective:

Selection of an experienced agency to provide selected fun fair play items to the play zone of 18th Toshali National Crafts Mela from 15th to 26th December 2023 at Janata Maidan, Chandrasekharpur, Bhubaneswar.

3. General Terms & Conditions:

- *i.* The date of organizing the event *i.e* from 15th to 26thDecember 2023 may change as per availability of Janata Maidan or any other un-avoidable circumstances or decision of the mela authority.

- iii. The bidder must submit their proposal by Speed Post/ Registered Post/ Courier only to the address as specified at Sl. No 13 of the DATA SHEET during the office hour only on or before the last date and time for submission of proposal as specified at Sl. No 5 of the DATA SHEET. Submission of proposal through any other mode and late bid will be rejected. The client will not be responsible for postal delay/ any consequence in receiving of the proposals.

- iv. The Agency shall deposit earnest money as prescribed in the EOl call Notice as a guarantee in good faith. The amount will be counted towards security for due performance of the contract. In the event of refusal to execute the agreement in schedule time, the same will be forfeited. If the offer of the bidder is not accepted the earnest money will be refunded without any interest.
- v. The above deposit of the selected Agency shall remain as security for the due rendering of services for the event and on successful completion of the event, the same will be refunded as per agreement

vi. **Contract Negotiation:**

Contract Negotiation, if required will be held at a date, time and address as intimated to the selected bidder. Representative conducting negotiations on behalf of the bidder must have written authority to negotiate and conclude a contract. Negotiation will be performed covering technical and financial aspect, if any and availability of proposed professionals etc.

- vii. The Agency must obtain for himself on his own responsibility and at his own expense all the information after visiting the site "Janata Maidan" and ascertaining for themselves the site condition, location surroundings, climate, access to site, applicable laws and regulations or any other matter considered relevant for submission of the offer.
- viii. The Agency has to provide the services only for 18th Toshali National Crafts Mela.
- ix. No modification to the bid documents shall be allowed once it is received by the authority.

x. **Governing Law and Penalty Clause**

The schedule given for delivery is to be strictly adhered to in view of the strict time schedule. Any unjustified and unacceptable delay in deliver shall render the bidder liable for liquidate damages and thereafter the client holds the opinion for cancellation of the contract for pending activities and entrust the same to any other agency. The client may deduct such sum from any money from their hands due or become due to bidder. The payment or deduction of such sums shall not relieve the bidder from his obligations and liabilities under the contract prevailing laws of Government of India/ Government of Odisha. Failure on bidder's part to furnish the deliverables as per the agreed time line will enforce a penalty @ 1% per day subject to maximum of 10% of the total contract value. The decision of the authority placing the contract, whether the delay in development has taken place on account of reasons attributed to the bidder shall be final.

xiii. The agency will have to make necessary arrangement for safe running of the play items as per safety norms/ guidelines associated of NBC/ Local Fire Authority/ Police.

xiv. Minimum one no fire extinguisher needs to be installed at each item for fire safety measure or as per the requirement of fire authority.

xv. Fire retardant solution to be sprayed in all fabric/ flex material used for the play items in any form at the cost of the agency.

xvi. All electric connections need to be safe, duly black taped insulated/ covered and to be done through licensed & expert electrician.

- xvii. The agency will be held responsible for any accident caused due to electricity or other reasons with the equipment and shall have to compensate the losses if any.
- xviii. The selected agency shall sign an agreement in Non-judicial stamp paper of appropriate value with deposit of the entire quoted amount, in shape of Bank Guarantee towards space rent, electricity dues & infrastructure cost on the next day of acceptance of the offer. Failure to do so shall give the Authority the right to revoke the acceptance of the offer without further notice to the selected agency, forfeit the earnest money deposits and award the work to any other agency.
- xix. An undertaking as per requirement of the Mela authority needs to be submitted prior to issue of work order & to deposit the quoted amount on the next day of the acceptance of the offer.
